## PRESENTATION ON SAANSAD ADARSH GRAM YOJANA (SAGY) ON 20<sup>TH</sup> NOVEMBER, 2014

- 1. Shri K. N. Kumar, Principal secretary C & RD department welcomed all the participants of the meeting especially the Hon'ble Minister and Hon'ble MP for attending the orientation programme and requested the Nodal Officer Shri T Lyngwa to make the presentation.
- 2. Shri T. Lyngwa Director SIRD made a power point presentation on the Guide lines of SAGY as published by Ministry of Rural Development, Govt. of India highlighting the goals, objectives, the values, strategy to be adopted and planning involved for the scheme. He also mentioned the 8 (eight) key aspects of the scheme which included personal development, human development, social development, economic development, environmental development, basic amenities and services, social security and good governance. The roles of MPs and DCs in SAGY were also explained in detail, during the presentation.
- 3. After due deliberations the meeting decided to take the following steps in order to carry forward and implement the SAGY:-
  - (1) The District SAGY implementation Committees will be constituted immediately with the MPs concerned as Chairmen and respective DCs as Conveners. (Action: C & RD Department)
  - (2) The Block Development Officers (BDOs) concerned will be designated as the Charge Officers, who will assist the District Committee for implementation of the scheme. (Action: C & RD Department)
  - (3) The respective Deputy Commissioners will conduct a baseline survey as soon as the format for the purpose is received from the NIRD. In this regard, a team of Master Trainers of SIRD will assist the DCs in the survey. The survey should be completed by 15<sup>th</sup> December, 2014. ( Action : Charge Officers and Deputy Commissioners and Director SIRD)
  - (4) The SIRD will constitute a team to assist the Deputy Commissioners in the preparation of the village Development Plan. (Action: Director, SIRD)
  - (5) The Minister felt that local MLAs concerned may be approached to contribute certain amount of fund from the MLA schemes with SAGY as a convergence programme. He also felt that amendments may be made in the revised SRWP guidelines to cover at least 10% of the scheme amounts for the target village. ( Action : C & RD Department & Director, C & RD)
  - (6) Since awareness for the scheme has to be completed within December, 2014, the BDOs concerned will have to identify 30 40 youth from the identified village for an intensive training at the SIRD. This will have to be done after the Baseline survey is completed. (Action: Director, SIRD, the Charge Officers and the DCs)
  - (7) SAGY website will have to be created (Action: Nodal officer)

(8) Nodal Officer, DC, PD DRDA and Charge Officer should visit the adopted village at the earliest, for awareness generation.
